## LEVEL 3 AWARD IN PAEDIATRIC FIRST AID

#### WHO IS THIS QUALIFICATION FOR?

This qualification is aimed at individuals wishing to become a paediatric first-aider in the workplace with a responsibility for the welfare of infants and children. This qualification is intended for learners already working or preparing to work in the industry and it meets the requirements for paediatric first aid outlined in the Early Years Foundation Stage.

#### **TOPICS COVERED**

Topics include the role and responsibilities of the paediatric first-aider and providing first aid for an infant or a child who is unresponsive. The qualification also covers how to administer first aid to an infant or a child with head and spinal injuries, who is choking or suffering from anaphylaxis.

















## LEVEL 2 AWARD IN FOOD SAFETY FOR CATERING

#### WHO IS THIS QUALIFICATION FOR?

By law, food business operators must ensure that food handlers receive the appropriate supervision and training in food hygiene. This qualification is suitable for those working in a catering environment who are responsible for handling food. It is also the most popular food safety qualification accepted by enforcement officers and auditors.

#### THIS QUALIFICATION COVERS:

- the importance of food safety procedures and complying with the law
- microbiological, chemical, physical and allergenic hazards and their control
- good temperature control and stock rotation
- the importance of good personal hygiene and preventing contamination, including handwashing, protective clothing, cuts and reporting illness
- keeping work areas and equipment clean and safe
- safe waste disposal
- Pest control





# INTRODUCTION TO SUPPORTING TEACHING AND LEARNING IN SCHOOLS

This unit looks at the skills and behaviour requirements for staff working as learning support assistants within a school setting.

#### THIS QUALIFICATION COVERS:

- the range of models of learning support.
- the role of a learning support assistant.
- the role of team work and confidentiality within a learning support context.
- the management of children's behaviour.
- the importance of equal opportunity within the classroom.
- the need for observing health and safety in a school.

### SAFEGUARD OF CHILDREN AND YOUNG PEOPLE

This unit provides the knowledge and understanding required to support the safeguarding of children and young people.

#### THIS QUALIFICATION COVERS:

- current legislation, guidelines, policies and procedures for safeguarding children and young people.
- the importance of working in partnership with other organisations to safeguard children and young people.
- the importance of professional wellbeing in relation to safeguarding.
- how to manage the identification of safeguarding concerns.
- how the rights of children and young people relate to their protection.



# SUPPORTING CHALLENGING BEHAVIOUR IN THE LEARNING ENVIRONMENT

To understand policies and strategies for supporting learners with additional learning needs within a learning environment.

#### THIS QUALIFICATION COVERS:

- policies relating to supporting positive behaviour within own organisation. (A.KU15)
- what constitutes challenging behaviour in the learning environment and its possible causes.
- strategies for managing behaviour. (A. KU10)
- actions required following incidents of challenging behaviour. (A.KU14)

## UNDERSTANDING AUTISM AWARENESS

Learners will understand the difficulties that could be experienced by an individual who has autistic spectrum conditions, the importance and need for the autism spectrum, ways of supporting individuals and approaches to communication.

#### THIS QUALIFICATION COVERS:

- the difficulties that can be experienced by individuals who have autistic spectrum conditions (ASCs).
- the importance of the autistic spectrum when supporting individuals who have an ASC.
- how to support individuals who have an ASC.
